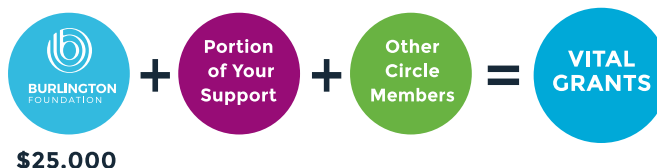


The Power of the Giving Circle
