## Burlington Foundation Covid-19 Pandemic Response Fund Phase 3 Granting; Arts, Heritage & Environment

Since the start of the pandemic, the Foundation has provided Phase 1 and 2 emergency funding totaling \$224,670 to 27 front-line charities. These grants support initiatives that are addressing immediate basic needs of individuals greatly impacted by Covid-19 - needs that include mental health, food insecurity, disability, isolated seniors and safe housing.

As we move into our Phase 3 granting, we also recognize the tremendous challenges our Arts, Heritage and Environment sector agencies are experiencing. While we know these sectors are creative and resilient, we recognize many are struggling to reimagine their services in a pandemic world or even continue operations with slashed revenues.

In response, Phase 3 of our granting focuses on supporting charitable organizations in the Arts, Heritage and Environment sectors that serve Burlingtonians. All eligible organizations will be required to attest to one of the following to be considered for a Phase 3 grant award:

- Require funding to support continuity of operations.
- Require funding to reimagine and modify program and service delivery during the ongoing pandemic.
- Require funding to continue delivering previously modified programs and services.

# Phase 3 Eligibility

- Applicants must be a CRA registered charitable organization.
- Applicants' core mission must be directly related to 1 of 3 sectors: Arts, Heritage or Environment.

(Note: organizations whose mission is not considered to fall under one of these 3 sectors, but offer a related program, i.e., arts-based initiative, are not deemed eligible.)

• Applicants remain in operation at the time of application and plan to continue contributing to the well-being of Burlingtonians.

# Maximum Grant Request

Agencies are permitted to request up to \$15,000 per application. We anticipate a significant number of requests which may exceed our current resources for Phase 3. Despite merit, not all organizations will receive funding and/or may not receive their full requested amount.

### **Grant Application - Timelines & Decisions**

Applications for Phase 3 will be accepted from **Monday, October 5th** to **Friday, October 23rd (5 p.m.)**. Grant applications will be reviewed and decisions will be made the week of October 25<sup>th</sup>. Organizations will be notified as efficiently as possible.
